## What is this product?

### Type

UCITS fund

### Term

This fund has no maturity date. However, the board of directors may decide to close the fund under certain circumstances.

### Intended investor

This fund may be suitable for those who plan to hold their investment for at least 5 years and who understand that the money invested in the fund may increase or decrease in value and that there is no guarantee that you will get back all the capital invested. To invest in the fund, you do not need to have any particular prior knowledge or experience of funds or financial markets.

### Objectives

The fund invests in equity and fixed income funds managed by Spiltan Fonder.

### Other information

*Depository:* Swedbank AB (publ)

The fund may also invest in funds managed by external fund management companies or in financial assets other than fund units. A minimum of 50% of the assets are invested in fund units. A maximum of 80% of the assets may be invested in equity funds.

*Dividend income:* The fund does not pay any dividends.

The fund may invest in transferrable securities, money market instruments, fund units, and in accounts with credit institutions.

*Conversion right:* The investor has no right to convert his investment.

The overall objective of the fund is to achieve a growth in value which, over time, exceeds a composite index comprising 42.5% SIXPRX, 8.5% CSRX, 19% MSCI World NR, and 30% (75% SSVX + 75% SPSEICRT Index).

*Additional information:* Additional information about the fund, copies of its prospectus, the latest annual and semi-annual report and the latest prices of shares may be obtained free of charge from the Management Company or on [www.spiltanfonder.se](http://www.spiltanfonder.se). The prospectus and the periodic reports are prepared for the entire fund and are available in Swedish. The Management Company may inform you about other languages in which these documents are available.

The fund may not invest in derivative instruments, including OTC derivatives.

This fund was launched in 2019.

*Benchmark:* The portfolio is actively managed on a discretionary basis with reference to a benchmark. While the product compares its performance against the 42.5 SIXPRX, 8.5% CSRX, 19% DMNS, 30% (75% SSVX + 75% SPSEICRT Index), it does not try to replicate this bench-

# What are the risks and what could I get in return?

## Risk indicator

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Risks not captured by the risk indicator:

- Operational risk is the risk of loss due to, for example, system failure, errors caused by the human factor or by external events.
- Counterparty risk arises if a counterparty does not fulfill its obligations to the fund, for example by not paying a set amount or not delivering securities as agreed.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

## What happens if Spiltan Fonder AB is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depository Swedbank AB (publ). Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. If the fund is part of another product, e.g. unit-linked insurance, there may be other costs for that product.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 100,000 SEK is invested
