What is this product?

Type

UCITS fund

Term

This fund has no maturity date. However, the board of directors may decide to close the fund under certain circumstances.

Objectives

The fund is an equities fund that invests globally in equities and other transferable securities issued by investment companies and companies of an investment nature, including conglomerates, without any geographical or sector restrictions.

Investment companies and companies of an investment nature offer shareholders risk diversification through a well diversified securities portfolio or ownership of companies in different sectors.

The fund's investment policy consequently enables it to offer good risk diversification.

The overall objective of the fund is to achieve a growth in value which, over time, exceeds the equivalent for the global equities market.

The fund may not invest in derivative instruments, including OTC derivatives.

Benchmark: The portfolio is a passively managed global fund that invests in a selection of investment companies and companies with investment company-like characteristics, including conglomerates. An active selection of the fund's positions has been made, as the fund is managed passively. The management aims to reflect the fund's long-term investment focus and to outperform the fund's benchmark index.

The fund's benchmark index is Bloomberg Developed Markets Large & Mid Cap Net Return Index SEK (DMNS Index). This index is relevant to the fund as it reflects the fund's long-term investment focus in terms of asset class and geographical market.

Intended investor

This fund may be suitable for those who plan to hold their investment for at least 5 years and who understand that the money invested in the fund may increase or decrease in value and that there is no guarantee that you will get back all the capital invested. To invest in the fund, you do not need to have any particular prior knowledge or experience of funds or financial markets.

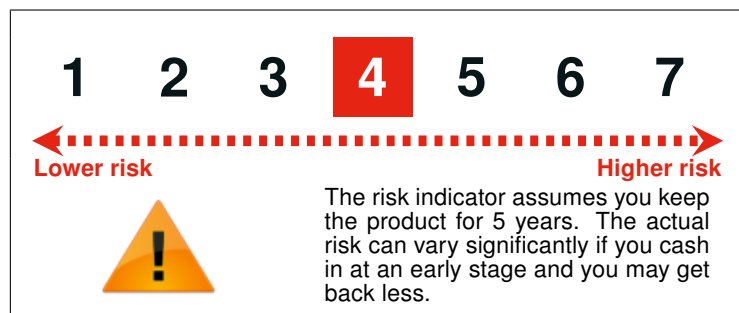

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we

are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Risks not captured by the risk indicator:

- Operational risk is the risk of loss due to, for example, system failure, errors caused by the human factor or by external events.
- Counterparty risk arises if a counterparty does not fulfill its obligations to the fund, for example by not paying a set amount or not delivering securities as agreed.

This product does not include any protection from future market performance so you could lose some or all of your investment.

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

The unfavourable, moderate and favourable scenarios shown are illustrations using the worst, average, and best performance of the product and of a suitable benchmark over the last 10 years. Markets could develop very differently in the future.

Unfavourable scenario: This type of scenario occurred for an investment between November 2024 and December 2025.

Moderate scenario: This type of scenario occurred for an investment between March 2016 and March 2021, by referring to a benchmark.

Favourable scenario: This type of scenario occurred for an investment between March 2020 and March 2025.

The stress scenario shows what you might get back in extreme market circumstances.

What happens if Spiltan Fonder AB is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Swedbank AB (publ). Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. If the fund is part of another product, e.g. unit-linked insurance, there may be other costs for that product.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 100,000 SEK is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 13.9% before costs and 13.4% after costs.

Recommended holding period: 5 years
